

Privacy Policy for First international Play Money Exchange OÜ

At First international Play Money Exchange OÜ (also "us", "we", or "our"), accessible from www.fipme.net (hereinafter also referred to as the "Service"), one of our main priorities is the privacy of our visitors. General Data Protection Regulation (GDPR)

We are a Data Controller of your information.

First international Play Money Exchange OÜ legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal Information we collect and the specific context in which we collect the information:

- First international Play Money Exchange OÜ needs to perform a contract with you
- You have given First international Play Money Exchange OÜ permission to do so
- Processing your personal information is in First international Play Money Exchange OÜ legitimate interests
- First international Play Money Exchange OÜ needs to comply with the law

First international Play Money Exchange OÜ will retain your personal information only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your information to the extent necessary to comply with our legal obligations, resolve disputes, and enforce our policies.

If you are a resident of the European Economic Area (EEA), you have certain data protection rights. Log Files

First international Play Money Exchange OÜ follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information

is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

Cookies and Web Beacons

Like any other website, First international Play Money Exchange OÜ uses 'cookies'. These cookies are used to store information including visitors' preferences, and the pages on the website that the visitor accessed or visited. The information is used to optimize the users' experience by customizing our web page content based on visitors' browser type and/or other information.

Definitions

Service

Service is the www.fipme.net website operated by First international Play Money Exchange OÜ

Personal Data

Personal Data means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).

Usage Data

Usage Data is data collected automatically either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

Cookies

Cookies are small files stored on your device (computer or mobile device).

Information Collection and Use

We collect several different types of information for various purposes to provide and improve our Service to you.

Types of Data Collected

Personal Data

First international Play Money Exchange OÜ will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of your data and other personal information.
